DIRECTOR ANIMAL HUSBANDRY:

Non completion of civil works at Modern Veterinary Services scheme

ADP # 1319 Establishment of Cattle Colonies with District & Private Participation Phase-I.

It is pointed out that the amount of Rs. 7.000 million have been released for the construction of Cattle Colony Mehrand (Tharparkar) whereas this location has been dropped in the revised PC-I and the amount be diverted to Cattle Colony Khairpur which has the highest priority at present.

ADP # 1320 Strengthening of Research & Training Institute for Livestock Dev. @ Tando Muhammad Khan

This scheme has been extended for only One year and must be completed by 30th June, 2015. The works department has to complete the work. Rs. 3.00 million has been re-appropriated. Keeping in view the short time left behind, the targets may be completed within stipulated time i.e. 30.6.2015.

ADP # 1327 Establishment of Stationary and Mobile Veterinary Diagnostic Lab: Units for Disease Confirmation and Control in Milk & Meat Zone of Sindh Province.

During the financial year 2013-14 an amount of Rs.2.000 million was released / utilized and during the current financial year 2014-15 Rs.1.8245 million for 1st quarter has been released on September 24, 2014 but MPR of December, 2014 indicated the physical progress as "Foundation in progress" as it was in June, 2014.

As per scope of the scheme the construction of District Laboratory at Badin has to be completed during the financial year (2014-2015), due to this slow pace of construction of District Laboratory, the other objectives and activities under the Development Project is going to be affected and the targeted annual goals set under the Development Scheme may not be achieved as per PC-I.

ADP # 1333 Construction of Veterinary Centre @ Village Muqueem Khuda Bux Dahri, Taluka Qazi Ahmed, District Shaheed Benazirabad

It is identified that Rs. 02.744 million has been released by Finance Department to complete Veterinary Centre at Village Muqeem Khuda Bux Dahri District Shaheed Benazirabad, however work has not been started yet on the site.

It is therefore requested that for the scheme ADP # 1319 (Phase-I) the released amount of Rs.7.000 (m) be diverted to Cattle Colony Khairpur as per revised PC-I of the scheme and for rest of the schemes concerned Chief Engineer Buildings may kindly be directed to expedite the completion of work as per releases and also necessary action be taken against those who are responsible for delay in work.
